 - Chief Armstrong provided a presentation on current conditions and the upcoming wildfire season, presentation attached.
- 6.2 Alert and Warning Update/Discussion
 - I. Annie Puckett reported that the contract with Genaysis Emergency Management (GEM), parent company of Zonehaven, has been signed, as has an MOU with Netcom. She stated that implementation began the week of April 24, 2023 and that beta testing of the new system should begin by the first week of June.





Annie also stated that the County is seeking an updated name for the new alert and warning system, moving away from brand specific CodeRed. She said a survey would be shared with the EMC where members could weigh in on the new system name.

Outreach will occur to improve subscribership to the new system. Additionally, participants will be added via extraction from the current CodRed system and from voter rolls.
