- 10.4 Grant Updates: Homeland Security/Emergency Management Performance 10.4.1FY 2019 State Homeland Security Grant Program (SHSGP) (2.75-year grant through 5.31.2022 award of \$359,856). Completed projects: Mobile X-Ray Machine (ID Hazardous/Explosive Devices) for the Sheriff's Office; Mobile Bomb Containment Vessel for the Sheriff's Office; Equipment for CERT training graduates; Ballistic Shields for Scotts Valley PD; Personal Body Armor for Santa Cruz PD
 - 10.4.2 FY 2020 State Homeland Security Grant Program (SHSGP) (2.75-year grant through 5.31.2023) award of \$356,972. New final application package was submitted on 1.28.2021 to align with 4 new National Priority Investment Justifications required by DHS/FEMA. Final approval now granted; accepted and appropriated by Board of Supervisors agenda for acceptance and appropriations 01.25.21.

Projects submitted in the CalOES has reviewed and provided feedback for amendment for project with required Investment Priority; Amended and complete application to be submitted by 12.31.21.
